

Applicants to the English Language Center should be at least 17 years old.

To ensure receiving your I-20 in sufficient time to obtain an F1 visa, your application should be received six (6) to eight (8) weeks before the session start date. **PLEASE CHECK THE WEBSITE FOR DEADLINES!!!**

Your application must include the following:

1. An **original** financial statement from a bank, embassy or sponsor stating a US dollar amount, signed by a bank official and bearing the bank's official seal.
2. A non-refundable application fee of \$110.00, which includes Federal Express delivery. Make checks payable to the University of Denver.
3. Your completed application form.
4. A copy of your name page of your passport or birth certificate. If you are a transfer student, you must include a copy of your I-20 and visa. If you are bringing dependants please provide a copy of each additional person's passport.

Please note:

All applicants needing an I-20 form to obtain a student visa must provide evidence of financial support for the period of study in the US. This letter must be an **original** document with the bank or embassy address and telephone number and be signed by a bank official. The financial statement must indicate a dollar amount calculated in US dollars. This letter must confirm that you have at least \$7,307.00 for EACH quarter you plan to study at the English Language Center. The amount that must be confirmed to receive an I-20 for a year is \$21,921.00.
