I understand the terms of the Promissory Note and agree that the following provisions have been discussed.

1. Total amount of the debt, and the interest rate.
2. Length of the grace period, and the first payment due date.
3. Repayment schedule, payment due dates, and total interest paid if adhere to schedule
4. Option to pre-pay principal without penalty.
5. Payments to be made to University of Denver, Bursar's Office 2197 S. University Blvd. #223, Denver CO 80208, (303) 871-4901 or to the address given on the billing. Our web address (which has forms available for download) is <http://www.du.edu/bursar>.
6. Deferment provisions, including Student, Military, Temporary Disability, Hardship.
7. Cancellation provisions, including Peace Corps/Vista, Law Enforcement, Nursing, Teacher of Special Educ., of Head-Start, or of shortage area (e.g. Math).
8. My responsibility to inform the Bursar's Office of any change in name, address, telephone number, or social security number.
9. My responsibility to inform the Bursar's Office in advance if I cannot make a scheduled payment.
10. If a payment is not made when due, late charges, service charges and additional interest will be assessed.
11. If the account is referred to a collection agency, the total loan may be declared immediately due and payable(accelerated), and I will be responsible for paying all collection costs and attorney fees.
12. The status of the loan, whether current, delinquent, or in deferment, will be reported to a credit bureau on a regular basis.
13. Loan consolidation is an option if I borrowed from more than one loan program but I will forfeit any provisions available for the Perkins loan.
14. If I default on my loan, I can request a one time **Loan Rehabilitation** and upon completion of rehabilitation, Credit Bureaus will be instructed to remove the default from my credit history.
15. If I dispute the terms of my loan in writing and the University does not resolve the dispute, I can contact the **Student Loan Ombudsperson's** office by calling 1-877-557-2527 or visit webpage at <http://sfahelp.ed.gov>.
