RE: Higher Education Emergency Relief Fund III (HEERF) Required Reporting  
April – June 30, 2021

---

The University of Denver will receive funding totaling \$12,232,909 from the third allocation from the Higher Education Emergency Relief Fund as part of the American Rescue Plan Act (ARPA). Allocations totaling \$6,129,883 will be received to support student aid and \$6,103,026 will be received for institutional support.

As of June 30, 2021, the University of Denver has not drawn HEERF III funding. Our expectation is to draw a portion of the student and institutional support funding as early as July, but within the 90-day award allocation window, while adhering to the Department of Education internal controls guidance, cost principles and audit requirements for Federal awards.

HEERF III – Student Portion  
Second quarter 2021 - April through June

1. The American Rescue Plan Act was signed on March 11, 2021. The Act authorizes additional funds under the Higher Education Emergency Relief Fund. The higher education allocation in this law is known as HEERF III. The University is expecting to receive \$6,129,883 in HEERF III funds for direct support to students. No HEERF III funds have been drawn or disbursed as of June 30, 2021.
2. The University will receive a total of \$6,129,883 in ARPA HEERF III funds for distribution to students.
3. The University has not distributed HEERF III funds as of June 30, 2021.
4. The University expects nearly any student enrolled since March 13, 2020 to be eligible for consideration for HEERF III, but we must prioritize funding for students with exceptional need.
5. No students have received ARPA HEERF III funding as of June 30, 2021.
6. The University will provide appropriate updates on the method used to distribute student funds in upcoming quarterly reports.
7. The University notified some students in the HEERF II application round in May 2021 that additional HEERF III funds may be available. The University is developing instructions, directions, and guidance for students regarding the distribution of HEERF II funds.

## Form Instructions

**Completing the Form:** On each form, fill out the institution of higher education (IHE or institution) name, the date of the report, the appropriate quarter the report covers (September 30, December 31, March 31, June 30), the 11-digit PR/Award Number (number is found in Box 2 of your Grant Award Notification (GAN)) for each HEERF grant funding stream as applicable, the total amount of funds awarded by the Department (including reserve funds if awarded), and check the box if the report is a “final report.” Institutions that expended HEERF grant funds during the calendar quarter from January 1 – March 30, 2021 are required to post the quarterly report that involved the expenditure of HEERF II CRRSAA and HEERF I CARES Act funds. The Department did not previously affirmatively indicate this reporting requirement was in place for HEERF II CRRSAA funds. As such, institutions may have until the end of the second calendar quarter, June 30, 2021, to post these retroactive reports if they have not already done so. **Posting the Form:** This form must be conspicuously posted on the institution’s primary website on the same page the reports of the IHE’s activities as to the emergency financial aid grants to students made with funds from the IHE’s allocation under (a)(1) of the CARES Act, CRRSAA, and ARP (Student Aid Portion) are posted. It may be posted in an HTML webpage format or as a link to a PDF. A new separate form must be posted covering each quarterly reporting period (September 30, December 31, March 31, June 30), concluding after either (1) posting the quarterly report ending September 30, 2023 or (2) when an institution has expended and liquidated all (a)(1) Institutional Portion, (a)(2), and (a)(3) funds and checks the “final report” box. IHEs must post this quarterly report form no later than 10 days after the end of each calendar quarter (October 10, January 10, April 10, July 10). Each quarterly report must be separately maintained on an IHE’s website or in a PDF document linked directly from the IHE’s HEERF reporting webpage. Reports must be maintained for at least three years after the submission of the final report per 2 CFR § 200.333. Any changes or updates after initial posting must be conspicuously noted after initial posting and the date of the change must be noted in the “Date of Report” line.
