Institutional Animal Care and Use Committee (IACUC) Pre-Approval Checklist

The University of Denver requires all individuals to complete mandatory training who are investigators conducting research involving animals. These training modules must be completed before IACUC approval will be issued for a new project or before new personnel are added to a protocol.

Through the Collaborative Institutional Training Initiative (CITI) Program (www.citiprogram.org), training modules are available for DU faculty, staff and students who are an investigator or key personnel working with animals. This training is also required to gain Vivarium Access.

<u>Prior</u> to working with animals, you must complete the following requirements. (This form can be used as a personal checklist. It is not required to be submitted as part of your IRBNet package.)

Continuing Education

At least one in-service training session offered by the University of Denver, must be attended by each IACUC researcher each year. The PI must provide the date of at least one in-service training attended for each person listed on the protocol during the Post Approval Monitoring (PAM) meeting with the IACUC Administrator.

IRBNet Registration and Submission

All research projects that will involve animals must be submitted to the DU IACUC for review and approval. All IACUC applications must be submitted online through the IRBNet system. In order to access this system, all end users must register at www.irbnet.org. Protocols submitted in hard copy or to an IACUC staff member's email will not be reviewed.
