Date of Incident: March 9, 2022 **Location of Incident:** Parking lot "C"

Synopsis:

On Wednesday, March 9, 2022, 3 different vehicle break-ins took place in parking lot "C." The first report was taken today, at approximately 1:39 p.m. During the first break-in, items were stolen from an unlocked vehicle. There were no signs of forced entry. At around 7:23 p.m., another vehicle, located in parking lot "C," was broken into. A reporting party called Campus Safety dispatch and reported the sound of breaking glass. Campus Safety responded and discovered a driver's side window broken in a vehicle in the southeast corner of the parking lot. It is unknown if items were taken from this vehicle. As Campus Safety was responding to the second vehicle break-in, the patrol vehicle that responded to the parking lot had the front passenger window broken. Items were stolen from the Campus Safety vehicle. The officer on scene, did not, however, witness the vehicle break-in.

Denver Police have been notified and will respond.
