Nature: Theft from Motor Vehicles

Date of Incident: March 9, 2022 **Location of Incident:** Parking lot "C"

Synopsis:

On Wednesday, March 9, 2022, 3 different vehicle break-ins took place in parking lot "C." The first report was taken at approximately 1:39 p.m. During the first break-in, items were stolen from an unlocked vehicle. There were no signs of forced entry. At around 7:23 p.m., another vehicle, located in the southeast corner of parking lot "C," was broken into. A reporting party called Campus Safety dispatch and reported the sound of breaking glass. Campus Safety responded and discovered the driver's side window of the vehicle was broken. It is unknown if items were taken from this vehicle. As Campus Safety was responding to the second vehicle breakin, the patrol vehicle used to respond was also broken into. The officer did not witness the incident and a number of items were stolen from the campus safety vehicle.

Denver Police have been notified and will respond.
