Summer Quarter 2023

If degree requirements are not met during the quarter for which the graduation application is entered, the student will be required to delay their graduation to a later quarter and a \$20 delay of graduation fee will be assessed.

*The completed Schedule of Oral Defense must be scheduled by the candidate and thesis/dissertation director and received in the Office of Graduate Education at least **four weeks prior** to date of oral defense.

The thesis/dissertation is due to the oral defense committee at least **two weeks prior to date of oral defense.
