Date of Incidents: October 6 and 7, 2024

Location of Incidents: 1900 Block S University Blvd and Ammi Hyde Building – 2467 S Vine St

Synopsis:

This timely warning encompasses two separate criminal acts. The first criminal act was the robbery of a person in the 1900 Block of S University Blvd (S University Blvd/E Jewell Ave). Around 2:45 AM on Sunday, October 6th, the person was approached by six individuals while walking home along S University Blvd. The suspects attacked her, taking her valuables and other possessions. Denver PD and Campus Safety were not able to locate the suspects.

The second criminal act occurred on Monday, October 7th at approximately 4:51 AM. Campus Safety received a report of a suspicious individual located on the east side of the Ammi Hyde building at 2467 S Vine St. The suspect was wearing black pants, a black hoodie, and a red sequined mask covering their entire face while carrying a black backpack. Campus Safety Officers (CSOs) approached the individual, who then proceeded to threaten the CSOs with a three-and-a-half-foot PVC pipe wrapped in black tape with a four-inch nail sticking out of the top. The individual ultimately threw his weapon at the CSOs and fled from the CSOs on foot away from the campus. A photo is included below of the suspect without his mask.

Campus Safety is sending this alert pursuant to the Clery Act. None of the suspects in these criminal acts were apprehended and could pose a continuing threat to our campus community.

Safety and Security Tips:

Victimization is never the fault of the survivor. These are some safety and security tips that could aid in reducing risk:

- 1. Be aware of your surroundings. If you see anyone suspicious, avoid them by entering a public place such as a business or campus building. Campus buildings currently require DU ID Card Access.
- 2. Do not use your phone or any other electronics when walking. These devices distract you and make you an easy target for criminals.
- 3. Try to walk in well-lit areas as much as possible.
- 4. Walk on the sidewalk whenever possible. Walk close to the curb, avoiding doorways, bushes and other potential hiding places.
