



# CAMPUS SAFETY ALERT

**Location of Incidents:** Alley between Josephine/University north of Iliff and the intersection of University/Evans

## Synopsis:

On February 5<sup>th</sup> at approximately 1:00 AM, Campus Safety Officers were contacted by an unaffiliated individual, who reported his vehicle was shot at by an unidentified suspect with what was likely a BB gun while driving through the intersection of S University Blvd and Evans Ave. While Campus Safety Officers were responding and before Denver Police arrived, a DU student contacted Campus Safety at approximately 1:10 AM, and reported his vehicle had been shot at while driving in the alley between S University Blvd and S Josephine St north of E Iliff Ave. The suspect was driving what is believed to be a silver Nissan Versa with body damage on the driver-side doors. A still image of the suspect's vehicle is provided below.

Campus Safety is sending this alert pursuant to the Clery Act. The suspect in these criminal acts was not apprehended and could pose a continuing threat to our campus community. Safety and security tips are located on the next page.

## Safety and Security Tips:

Victimization is never the fault of the survivor. These are some safety and security tips that could aid in reducing risk:
