Locations of Incidents: Lynn Marie Apartments and Nagel Hall

Synopsis:

On Monday, January 12th, Campus Safety received a report of an electric bicycle that had been stolen overnight from a bike rack at the Lynn Marie Apartments. Campus Safety received a report on Thursday, January 15th, that an electric scooter had been stolen during the day from a bike rack at Nagel Hall. In both cases, Campus Safety has not been able to identify any suspects.

Campus Safety is sending this alert since under the Clery Act, electric scooters and electric bicycles are considered motor vehicles, and we believe these thefts represent a continuing threat to our campus community.

Safety and Security Tips:

These safety and security tips are strategies for reducing risk and victimization is never the fault of the victim/survivor.

1. If you see suspicious behavior, Call 911 or 303-871-3000 (ext. 1-3000) if on campus.
2. Do not attempt to confront individuals in the act of a crime, call 911 or 303-871-3000 (ext. 1-3000) instead to report it.
3. Park in well-lit areas.
4. Consider purchasing and using an ignition cut off switch or a wheel immobilization device.
5. Use a U-lock to secure your electric bicycles and electric scooters. Cable locks can be cut within a couple seconds and are not as secure as a U-lock.
