Certificate of Good Standing is public record and can be obtained by anyone. Please visit the Colorado Secretary of State website (link below)

A certificate does not expire. Our certificate is not kept on our website, as the official version is on the state website and will automatically update the date based on the date the user requests. The certificate reflects the status of the record at the time the certificate is requested, and the entity requesting will want the most recent certificate. 1. Search by business name: *University of Denver*
2. Click search
