Deadline to apply for Winter Quarter 2020 Graduation – September 16, 2019
Deadline to apply for Spring Quarter 2020 Graduation – January 13, 2020
Deadline to apply for Summer Quarter 2020 Graduation – April 6, 2020
Deadline to apply for Fall Quarter 2020 Graduation – June 22, 2020

Deadline for thesis/dissertation formatting approval November 21
Quarter closes November 21

Winter Quarter 2020

Deadline to submit Oral Defense Committee Recommendation form to the Office of Graduate Education January 6
Final Date: Schedule of Oral Defense due in the Office of Graduate Education (Mary Reed 5) January 31*
Deadline to submit the thesis/dissertation due to the oral defense committee February 14**
Final date for Oral Defense February 28
Deadline to submit the approved thesis/dissertation with all content revisions requested by committee to ETD/ProQuest & accepted by the Office of Graduate Education March 6
Deadline for thesis/dissertation formatting approval March 20
Quarter closes March 20

Spring Quarter 2020

Deadline to submit Oral Defense Committee Recommendation form to the Office of Graduate Education March 30
Final Date: Schedule of Oral Defense due in the Office of Graduate Education (Mary Reed 5) April 23*
Deadline to submit the thesis/dissertation to the oral defense committee May 7**
Final date for Oral Defense May 21
Deadline to submit the approved thesis/dissertation with all content revisions requested by committee to ETD/ProQuest & accepted by the Office of Graduate Education May 28
Deadline for thesis/dissertation formatting approval June 11
Quarter closes June 11
Commencement June 12

Summer Quarter 2020

Deadline to submit Oral Defense Committee Recommendation form to the Office of Graduate Education June 15
Final Date: Schedule of Oral Defense due in the Office of Graduate Education (Mary Reed 5) July 3*
Deadline to submit the thesis/dissertation to the oral defense committee July 17**
Final date for Oral Defense July 31
Deadline to submit the approved thesis/dissertation with all content revisions requested by committee to ETD/ProQuest & accepted by the Office of Graduate Education August 7
Deadline for thesis/dissertation formatting approval August 21
Quarter closes August 21
Commencement August 22

If degree requirements are not met during the quarter for which the graduation application is entered, a \$20 delay of graduation fee will be assessed.

*The completed Schedule of Oral Defense must be scheduled by the candidate and thesis/dissertation director and received in the Office of Graduate Studies at least four weeks prior to date of oral defense.

**The thesis/dissertation is due to the oral defense committee at least two weeks prior to date of oral defense.
